Common Area Maintenance (CAM) Fee / Off-waterfront lots.....\$30.00 Monthly

Common Area Maintenance (CAM) Fee / Waterfront lots.....\$40.00 Monthly

- Covers all common area maintenance, including Pavilion Park, entry wall areas, pedestrian areas, lake maintenance, boulevard, etc.
- Payable monthly by all lot owners including ‘maintenance-optional’ lots.
- Payable at closing on lot purchase on a pro-rated basis, calculated from the month following lot closing.
- \$20 DISCOUNT IF CAM FEE PAID UP FRONT FOR THE ENTIRE YEAR.

Individual Lots Maintenance (ILM) Fee\$105.00 Monthly

- Covers all individual lot maintenance (lawn, landscaping, irrigation and snow removal.)
- Payable by all lot owners monthly, on a non-prorated bases, after completion of the home, beginning the month when any of the above services commence on lot.
- Notice to begin full assessments will be given to builder or homeowner when service commences.
- *PLEASE NOTE THAT ONLY CERTAIN LOTS /AREAS ARE AVAILABLE FOR THE OPTIONAL MAINTENANCE.*

PLEASE NOTE: These fees represent an individual lot’s full year’s assessment, prorated on a monthly basis. They are not for the actual services rendered in any particular month.

One time Reserve Fund Assessment.....\$135.00

- Reserved for emergency, unexpected or unbudgeted repairs, replacement, and/or maintenance.
- Reserve fund balance to be transferred to the HOA after the Turnover Date.
- Payable at lot closing for all individual lot buyers.
- Reserve Fund Assessments on Builder owned lots are deferred to closing on home with new buyer. Request for dues letter from lender or the title company will prompt this billing.
